Overhead versus return as region smaller:

- Insurance Benefit is good
- Blue Bars
- Can have sanctioned or non-sanctioned
- Members of club can still be Members at Large with NCCC
- With any claims, members insurance is first payer, NCCC insurance secondary
- 501c3 Status not tied to NCCC membership – two separate, independent items
 - 501c3 status not currently active
 - Eliminates need for formal Board of Directors

- Eliminates need for minutes
- Members pay their own way to events/socials
