President's Report Old Business (Preston Tifft):

- I. Charitable Donations
 - a. List of possible charities to support this year
 - i. Nancy J. Brua Animal Care Center (is currently at capacity)
 - ii. Forgach House (Safe house for women and children affected by domestic violence)
 - iii. Lori's Place (Cochise Family Advocacy Center)
 - iv. Warrior Healing Center
 - b. Discussion
 - i. Donations of \$500 should be made quarterly by the club to 1 charity (\$2000/year).
 - Bylaws only specify that (1) there be a 2 week separation of nomination and voting of the charity and (2) that we maintain a minimum balance (\$1200) for operational costs of the club.
 - ii. Concerns
 - With only 1 event a year and having very little out of town participation from other clubs we will not be able to raise enough funds to make significant contributions to the charities.
 - 2. Emergencies come up throughout the year that we need/want to offer support to that may not be able to wait until the next quarter.
 - iii. Voting
 - Stu Cannold made the motion of quarterly donations, and Bill Scott seconded the motion. The motion was voted on and at the time passed, but shortly after the vote the club Governor pointed out we failed to hold a discussion before voting. This basic parliamentary procedural error nullified the vote.
 - 2. The ensuing discussion left several members needing further clarification and after further consideration the president decided to table the action until further discussions could establish more equitable procedures for charitable organization donations. Stu Cannold objected to the club president unilaterally throwing out the vote.
 - Bill Scott offered to draft some revisions to Article IX Charitable Contributions, of the bylaws and provide to the group for consideration.
