  - c. Certificate of insurance is on file with the mall and airport.
  - d. Awards to include non-Corvette participants
    - i. Sanctioned event so it must meet the NCCC requirements for the number of awards given.
    - ii. Last year Awards for non-Corvette entries
      - 1. Best of Show
      - 2. Best Paint
      - 3. Best Interior
      - 4. Best Engine
    - iii. Suggested we separate the generation classes
      - 1. Flyer grouped 7/8, 4/5/6, 1/2/3
      - 2. Now we will separate 7 and 8 as the number of C8 entries increases
  - e. Car Show
    - i. Bill Scott will organize the setup at the mall on November 18.
  - f. Awards Dinner
    - i. Dinner on Saturday night will be at Ricardo's Mexican Restaurant in Hereford.
    - ii. The cost will be \$25/person and includes gratuity.
    - iii. The buffet will include salad, steak, baked potato and more.





- g. Autocross
  - i. Wallace will need the timing system out of the trailer and the laptop to test the equipment.

**President's Report New Business (Preston Tifft):**

- I. Al Goodwin was voted into the club unanimously.
- II. Prescott Car Show
  - a. Preston Tifft attended last year and it was a very large show with over 300 Corvettes and suggested we consider attending in the future.
  - b. Each class judged separately.
